1. Promotion Overview

This promotional offer is provided by Watkins Therapy Group (WTG) **ABN: 37 826 814 954** and is valid for a limited time only. Promotion starts 01/05/2025 and ends at midnight 31/05/25. The promotion offers a **20% discount** on **Individual or Couples Telehealth*** (online or phone) therapy appointments with select therapists. The offer is available exclusively for appointments made with therapists **Cayetana, Frederick, Ellen, Robin and Syann**.

**The promotional discount is not valid for NDIS Telehealth appointments.*

2. Promotion Period

The promotion is valid for bookings made, paid for and attended until **31st May 2025**. After this period, the promotion will end, and standard pricing will apply to all services.

3. Eligibility

This promotion is available to new and existing clients of WTG. Clients are eligible to participate if they:
